# ICM Asset Management and Waterloo Partners Close on the Construction Financing of River Park E-Commerce Center, Building 6

### Patterson Arranges Construction Debt Financing with Ameris Bank

**Atlanta, GA:** ICM Asset Management ("ICM") and Waterloo Partners ("Waterloo") closed on the construction financing of River Park E-Commerce Center, Building 6 ("River Park 6"), a 725,000 SF industrial development in Butts County (Jackson), GA. Patterson arranged the construction debt financing with Ameris Bank.

River Park 6 is part of a larger,  $\pm 1,200$ -acre master-planned site that is marketed as the largest mixed-use development in the Atlanta MSA, with capacity to deliver up to 20 million SF of industrial space and one million SF of commercial and retail. The master site is located at Exit 205 with frontage along I-75, south of Henry County – highly accessible while also lacking the commercial traffic congestion to the north. The site is strategically positioned one turn off I-75 and will have a dedicated trucking lane to the south, enabling truckers serving the burgeoning Savannah port to deliver freight and return to Savannah in one day.



ICM and Waterloo have partnered with Constructive Ingenuity as a third-party construction manager, Evans as a general contractor, and Colliers for leasing.

"We're excited to officially kick off construction on River Park 6 and are glad we can continue to build our strong relationship with Ameris," said Spencer Patton, Partner & Managing Director, USA, of ICM.

"The greater River Park E-Commerce Center has experienced strong momentum given its location and accessibility, and we plan to capitalize on that momentum with River Park 6," said Brad Jancik, Principal at Waterloo Partners.
