# RCB Development Completes Recapitalization of Charleston Infill Industrial Portfolio Patterson Real Estate Advisory Group Arranges Financing with SilverCap Partners and Ameris Bank

**CHARLESTON, SC – NOVEMBER 2025:** Patterson Real Estate Advisory Group ("Patterson") is pleased to announce the successful refinancing of the Charleston Infill Industrial Portfolio ("Project" or "Portfolio"), a six property, ±400,000 SF, light industrial/industrial warehouse portfolio with five properties located in Charleston, SC and one in Beaufort, SC. In March 2025, RCB Development ("RCB") recapitalized the Portfolio's equity with SilverCap Partners ("SCP") and completed the refinancing in November 2025 with a new senior loan provided by Ameris Bank ("Ameris"). Patterson served as the exclusive capital advisor to RCB Development on both transactions.

The Portfolio's assets were strategically acquired by RCB between 2017 and 2023. All six properties within the Portfolio have successfully undergone repositioning efforts through addressing deferred maintenance, upgrading landscaping, signage, and building exteriors, as well as asset-specific improvements. Currently, the Portfolio is fully stabilized with an average occupancy of 99%.

"As we've assembled this portfolio over the past decade, we've seen growing institutional interest in the shallow bay industrial market," said Alex Fraser of RCB. "Partnering with SCP and Ameris allows us to deliver a successful outcome for our investors while establishing a strong foundation for future growth."
